Re: Notice of Layoffs

Dear Ms. Hoopes and Mayor Hancock:

This is to advise you that Curian Capital LLC will be permanently laying off employees at its location at 7601 Technology Way, Denver, CO 80237.

This action is expected to result in the permanent termination of 224 employees as listed on <u>Attachment A, B, C, & D</u>. Due to regulatory requirements governing registered investment advisors, the process will be slow and measured, occurring in four (4) separate segments, commencing on September 1, 2015 and continuing until the layoffs are completed on or about June 30, 2016.

The first two segments will not individually trigger the notice requirements of the Worker Adjustment and Retraining Notification Act ("<u>WARN</u>"), nor will they trigger WARN's requirements in combination, as they will not occur within any applicable look-back period. Moreover, the first layoffs, on September 1, 2015, will affect primarily a remote sales force working and living in 24 different states outside of Colorado. We provide this information as background.

The third segment, occurring on April 30, 2016, may trigger WARN's notice requirements individually but not in combination with the other layoffs.

The fourth and final segment will occur on or about June 30, 2016, and will affect the remaining 11 employees. At that time, the Company expects to cease operations.

In any event, the Company is electing to provide notice to you and the entire group of employees affected by the layoffs.





Attached as <u>Attachment A, B, C, & D</u> are lists of the affected job titles for each layoff, together with the number of affected employees within in each job title, and the termination dates for each of the four segments. The names of the employees are available from the contact below. As noted above, all of the layoffs are expected to be permanent.
