BEFORE ME, the undersigned Notary Public, Jason Bacher personally appeared, and upon being duly sworn, deposes and says:

1. My name is Jason Bacher.
2. I live in Madison, Wisconsin.
3. I presented my driver's license to the Notary Public as proof of my identity.
4. I certify under penalty of perjury that the statements of fact in this Affidavit are based on my personal knowledge or based on my firsthand observations and beliefs I formed based upon them.
5. AdvisorLaw LLC is a Colorado Limited Liability Company.
6. I began working on behalf of AdvisorLaw LLC before August 1, 2016.
7. I stopped working on behalf of AdvisorLaw LLC on or about May 3, 2017.
8. AdvisorLaw LLC's office was located at 3400 Industrial Lane, Unit 10A, Broomfield, Colorado 80020 while I worked on its behalf.
9. Dochter Daniel Kennedy ("Mr. Kennedy") was an owner or co-owner of AdvisorLaw LLC while I worked on the company's behalf.
10. Mr. Kennedy invited me to work as an AdvisorLaw LLC agent.
11. I had known Mr. Kennedy and his wife, JaYoung Kennedy, for years before I began working on AdvisorLaw LLC's behalf.
12. Mr. Kennedy and I worked together for a business other than AdvisorLaw LLC before I began working on AdvisorLaw LLC's behalf.
13. While Mr. Kennedy and I worked for the other business, he regularly talked about how the derogatory Ripoff Report reviews or complaints about that business had harmed the business and caused it to lose clients and money.

14. I worked with Matt Durr, Zachary Barber, Josh Barber, Tosh Grebenik, Stacy Santmeyer, Charles Sisk, and others who worked on AdvisorLaw LLC's behalf while I worked on AdvisorLaw LLC's behalf.
15. During November of 2016, while we were at AdvisorLaw LLC's office, Mr. Kennedy began to tell me and others who worked on AdvisorLaw LLC's behalf that he had authored and published a derogatory complaint or review about Mark Wilson and Wilson Law Ltd. on the Ripoff Report website.
16. The Ripoff Report complaint or review Mr. Kennedy admitted that he authored and published about Mark Wilson and Wilson Law Ltd. is Ripoff Report Complaint Review 1336305 ("Ripoff Report 1336305").
17. A copy of Ripoff Report 1336305 is attached to this affidavit as **Exhibit 1**.
18. During November of 2016, Mr. Kennedy informed me and others who worked on AdvisorLaw LLC's behalf that he was upset that Mr. Wilson had started a business that competed against AdvisorLaw LLC.
19. During November of 2016, Mr. Kennedy informed me and others who worked on AdvisorLaw LLC's behalf that he had published Ripoff Report 1336305 because he wanted to put Mr. Wilson and Wilson Law Ltd. out of business.
20. On several occasions, Mr. Kennedy openly bragged about having authored and published Ripoff Report 1336305.
21. Ripoff Report 1336305 states its author is Patrick Erickson of New York, New York.
22. To my knowledge, Mr. Kennedy has never called himself or asked others to call him Patrick Erickson.
23. Mr. Kennedy impersonated Patrick Erickson when he published Ripoff Report 1336305 because he did not want prospective clients of Wilson Law Ltd. who could read Ripoff Report 1336305 to know Mr. Kennedy or someone who worked on AdvisorLaw LLC's behalf had authored and published Ripoff Report 1336305.
24. The following statements in Ripoff Report 1336305 are false:
 - a. that Mr. Wilson lied to Patrick Erickson;
 - b. that Mr. Wilson made claims of his experience, affiliations, credentials and acumen to Patrick Erickson;

- c. that Mr. Wilson conned Patrick Erickson into hiring Wilson Law Ltd. to save Patrick Erickson's career;
- d. that Wilson Law Ltd. was a sham of a company;
- e. that Patrick Erickson needed an experienced lawyer to navigate FINRA and IRS issues which resulted from a divorce;
- f. that Mr. Wilson portrayed himself to Patrick Wilson as an expert with vast experience;
- g. that Patrick Erickson paid Mr. Wilson or Wilson Law Ltd. \$15,000;
- h. that Patrick Erickson paid a professional investigator to investigate Mr. Wilson or Wilson Law Ltd.;
- i. that a professional investigator informed Patrick Erickson that Mr. Wilson lied to Patrick Erickson;
- j. that Patrick Erickson confronted Mr. Wilson;
- k. that Patrick Erickson had emails, recorded conversations, or other evidence that proved Mr. Wilson lied to Patrick Erickson;
- l. that Patrick Erickson sent Mr. Wilson evidence that proved Mr. Wilson lied to Patrick Erickson;
- m. that Mr. Wilson told Patrick Erickson "good luck getting any money back;"
and
- n. that Mr. Wilson told Patrick Erickson "I am very good at hiding from judgments and collections."

25. Others who worked on AdvisorLaw LLC's behalf indicated to me before January of 2017 that they had read Ripoff Report 1336305.

26. Others who worked on AdvisorLaw LLC's behalf indicated to me before January of 2017 that they knew Ripoff Report 1336305 contained false and derogatory statements about Mr. Wilson and Wilson Law Ltd.


27. Others who worked on AdvisorLaw LLC's behalf indicated to me indicated to me before January of 2017 that they knew Ripoff Report 1336305's publication would

- harm Mr. Wilson's and Wilson Law Ltd.'s reputations and prevent Mr. Wilson and Wilson Law Ltd. from attracting new clients.
28. No one who worked on AdvisorLaw LLC's behalf informed me that he or she contacted Ripoff Report to inform it that Mr. Kennedy had authored and published Ripoff Report 1336305 or that Ripoff Report 1336305 contained false and derogatory statements about Mr. Wilson and Wilson Law Ltd.
 29. Sometime in January of 2017, Mr. Kennedy informed me that Mr. Wilson might sue AdvisorLaw LLC for the publication of Ripoff Report 1336305.
 30. Mr. Kennedy asked me to tell Mr. Wilson and anyone else who might ask me that I had published Ripoff Report 1336305 and that Mr. Kennedy had not published Ripoff Report 1336305.
 31. Mr. Kennedy told me that if I were sued for Ripoff Report 1336305's publication Mr. Kennedy or AdvisorLaw LLC would pay all my legal defense fees and costs.
 32. Mr. Kennedy offered me \$2,000.00 if I agreed to lie to Mr. Wilson and others by telling them I authored and published Ripoff Report 1336305 and that Mr. Kennedy did not author or publish Ripoff Report 1336305.
 33. Mr. Kennedy was an attorney licensed to practice law in Colorado when he asked me to lie to others about the authorship and publication of Ripoff Report 1336305 and offered me \$2,000.00 to do so.
 34. Charles Sisk ("Mr. Sisk") talked with me after Mr. Kennedy had asked me to lie about the authorship and publication of Ripoff Report 1336305. Mr. Sisk informed me he was concerned that Mr. Kennedy had not given me accurate legal advice and that I might be exposed to more liability than Mr. Kennedy indicated if I lied to Mr. Wilson or others about the authorship and publication of Ripoff Report 1336305.
 35. I did not author or publish Ripoff Report 1336305.
 36. Mr. Kennedy knows I did not author or publish Ripoff Report 1336305.
 37. Others who worked on AdvisorLaw LLC's behalf while I worked on its behalf know I did not author or publish Ripoff Report 1336305.
 38. I did not learn about Ripoff Report 1336305 until after Mr. Kennedy had authored it, published it, and admitted to me and others who worked on AdvisorLaw LLC's behalf that he had authored it and published it.

- 39. Mr. Kennedy informed me and others who worked on AdvisorLaw LLC's behalf that he had lied to Mr. Wilson by telling him that I had published Ripoff Report 1336305 and that Mr. Kennedy did not publish Ripoff Report 1336305.
- 40. Mr. Kennedy informed me that Mr. Kennedy and others who worked on AdvisorLaw LLC's behalf had discussed a possible settlement with Mr. Wilson to avoid a lawsuit related to Ripoff Report 1336305's publication.
- 41. Mr. Kennedy informed me and others who worked on AdvisorLaw LLC's behalf that no settlement was reached.
- 42. Mr. Kennedy informed me he would try to "crush" Mr. Wilson, end Mr. Wilson's marriage, end Mr. Wilson's career, and cause Mr. Wilson to lose his license to practice law if Mr. Wilson sued.



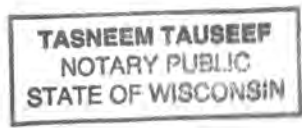

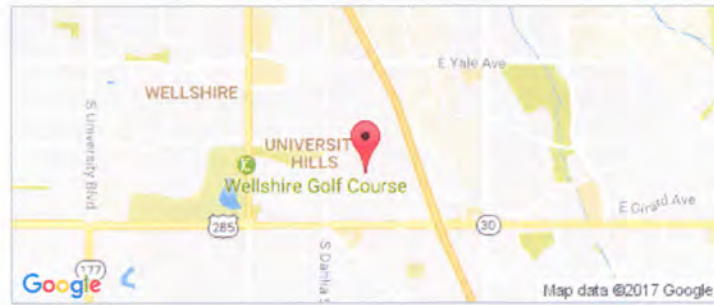


